A farm/ranch/stable operation is a dangerous environment, and that farm animals, farm equipment, various wire, buildings, stacked hay, tools, chemicals, medicines, manure, slick surfaces, uneven ground, vegetation, holes, wildlife, pets and many other hazards are present and potential sources for accidents that can cause bodily harm and even death and I am aware that being around horses and horseback riding is a dangerous activity that could result in serious injury or death.

2. I acknowledge that RBS/MSH carefully chooses its horses with human safety being the primary concern. However, I understand that horses are unpredictable and potentially dangerous. I also acknowledge my personal risk and accept that risk.

I further recognize and agree to obtain my own ASTM/SEI equestrian helmet as soon as possible.
