ACCOUNT TERMS and CONDITIONS



Fees for Services:

Fees for services are posted on the MSH/RBS website, https://www.winningarabians.com/feeschedule. Please refer to the Fee Schedule for current costs. Additionally, a Fee Schedule will be available to you and one will be included in your horse file.

Payments:

All MSH/RBS board, training and maintenance fees are due in advance. Payment for board and/or training is due on or before the 5th of each month. When MSH/RBS receives client's payment on or before the 5th of the month, clients with horses in full training for the entire month will earn a \$50 discount per horse. If a client's payment is received on or after the 6th of the month client's account will be charged a \$100 penalty for each horse belonging to client and all discounts for the current charges will be disallowed. Late fees, interest and discounts are determined by the date we receive payment and funds are available for use. If you have not received your emailed invoice by the first of the month, it is your responsibility to call MSH/RBS so that we can give you the amount due for timely payment.

Forms of Payment:

MSH/RBS accepts cash, checks, money orders, cashier's checks, most credit cards, Zelle and PayPal as payment. Client agrees to pay any charges incurred by MSH/RBS for the convenience of using credit cards, PayPal, wiring, etc. to make payments for services.

Show Costs:

Prorated charges:

Costs of tack stalls, patrons packages, preferred stabling, golf cart rental and other show charges utilized by the group will be prorated among the owners for the show and must be paid in full on or before the due date indicated with the charges.

<u>Direct show charges per horse paid by Client:</u>

<u>Paid to MSH/RBS</u>: Trainers' show fees and transportation are billed in advance and must be paid in full at least one week before show departure or your horse(s) may not be taken to the show. Clients should provide their own show equipment clearly marked with the owner or farm name. MSH/RBS is not responsible for loss, theft or damage to equipment, show clothes or other personal property.

<u>Paid to show</u>: Each owner shall <u>directly</u> pay entry fees, office fees, TBA classes, AHA or USEF fees, non-member fees and horse stalls with an open check made to the respective show or by completing a credit card authorization form.

<u>Paid to provider</u>: Bedding, medical or farrier charges, early arrival or layover charges will be paid directly by clients before leaving the show grounds.

Additional Monthly Fees/Charges: All veterinary, health care, vet follow-up visits, emergencies, laundry, cleaning and repair of blankets and pads, supplements, medications and their scheduling and dissemination as well as other like services are invoiced as charges in addition to board and training. These services may be subject to "cost plus a percentage" when billed to cover additional overhead and staffing costs.

<u>Delinquent Accounts:</u> Clients with an unpaid balance for thirty days or more may have their horse(s) withdrawn from shows until payment is made, and may, at the sole discretion of MSH/RBS, be withdrawn from monthly training and put on maintenance board until the account is brought current.

<u>After Hours Arrivals/Departures</u>: After hours are considered from 6 p.m. until 8 a.m. Monday through Saturday, Sundays and Holidays. After hours arrivals and departures of horses will be assessed a \$ 75 charge.

Release of Horses: All of your account charges must be paid in full before your horse(s) will be released from the care, custody and/or control of MSH/RBS. The courtesy of a 24 hour notice is appreciated.
